### **FOOD VENDOR APPLICATION FORM**

### **General Information for Food Vendors:**

- Music in the Park runs Thursday nights from July 4 to August 22, from 6:30 8:00 p.m.
- Music in the Park is held at Oliver Community Park at 6359 Park Drive behind the Oliver Community Hall.
- Vendors will have the ability to drive into the park for set up and again for take down; however, vehicles (other than food service trucks) are to be parked in the parking area and not remain on the site during the event.
- Food Vendors must provide their own water source. There is limited access to power available. Please indicate your power needs below.
- Food vendors must provide a copy of their Interior Health Permit to Operate, Food Safe certification, Technical Safety BC Electrical and Gas approval labels and Liability Insurance certificate to the Event Organizer no later than one week before their first scheduled booking. They must be able to comply with public health orders and communicable disease plans as may be required.
- Vendors may begin set-up at 5:00 p.m. Earlier set-up needed? Please let us know.
- Vendors are required to stay in the park for the duration of the concert.
- Vendors must vacate the site by 8:45 p.m. Please remove all waste. No dumping permitted. Nothing is to remain in the park.

To avoid competition, we will limit food vendors to at MOST two per concert, preferably one entrée truck and one dessert truck.

To ensure variety of food offerings, we reserve the right to limit the number of evenings available to any one food vendor. Every effort will be made to accommodate your requested dates.
