ARTISAN MARKET RULES AND REGULATIONS

Please initial each line (in the circle provided) for acceptance and understanding, sign and date and submit with your application. The following Rules and Responsibilities for the Artisan Market will be enforced, and we request your help in adhering to them. Please retain a copy of your application for future reference.

- ☐ 1. All products sold at the Market must be approved by the Market Vendor Committee. The committee reserves the right to request the removal of all products not approved for sale at the market. Any proposed additions or changes to approved items require preapproval of the Market Vendor Committee.
- ☐ 2. Electricity – Please be aware that there are limited spaces with power. Please ensure you note on your application if you require power.
- ☐ 3. Safety and Security – Vendor tables must be attended at all times. No tables shall be left unattended. Vendors are responsible for the security and safety of their products while at the Market. The Oliver Community Arts Council is not responsible for any loss, theft, or damage to vendor merchandise, displays or products at any time while at the Market.
- ☐ 4. Due to health guidelines and site restrictions, pets are not allowed. The Oliver Curling Rink is a non-smoking site and **no food or drink** will be allowed in the event area.
- ☐ 5. All vendors are to remove their own garbage from the Market premises at the end of the day.
- ☐ 6. Site assignment is at the sole discretion of the Market Vendor Committee.
- ☐ 7. The sale of any inappropriate product and the distribution of literature, political or religious material, or any article deemed not to be in the best interest of the Market, including Petitioning, Political Campaigning, and/or soliciting will be prohibited.
- ☐ 8. Stall Fees – Deadline for all Vendor Applications is August 28, 2026. Upon acceptance by the Vendor Committee market fees are due within 5 business days and are non-refundable.
- ☐ 9. Cancellation Notice – Vendor must advise the Oliver Community Arts Council as soon as possible, if they are unable to join our event.
- ☐ 10. Vendors must show current Consumer General Liability Insurance with this application, with a minimum \$2 million liability and that you are covered off site and at our event on the event dates.
